TOWN OF LONG LAKE BOARD MEETING MINUTES

February 8, 2022

Town Hall

The regular monthly Town Board meeting was called to order at 6:00 p.m. Supervisor I, Dan Lubensky. Supervisor II, Greg Tinker were present along with Clerk, Debbie Bouma, and Treasurer, Brenda Derousseau.

CONSIDER/APPROVAL RESOLUTION 2022-1 APPOINTING AN INTERMIN TOWN CHAIRMAN PURSUANT TO WI STATE STATUE 60.35(5)(C): Motion by Tinker and second by Lubensky to approve Resolution 2022-1 Appointing an Intermin Town Chairman pursuant to WI State Statue 60.30 (5)(c) which names James Whitehead as our new Town Chairman to complete LeRoy Sandridge's term. Motion Carried.

OATH OF OFFICE FOR THE INTERMIM CHAIRMAN: The clerk gave the oath of office to New Town Chairman, James Whitehead. Chairman Whitehead introduced himself to the public attending the meeting.

BOARD MEETING MINUTES: Motion by Tinker and second by Lubensky to approve the minutes from January 4th, 2022, Regular Board Meeting, and February 1st, 2022, Special Board Meeting as presented. Motion carried.

FINANCIAL REPORT: Motion by Tinker and second by Lubensky to accept the Treasurer's Financial Report as presented by the Treasurer. Motion carried.

PUBLIC INPUT: Two citizens spoke about a civil matter between neighbors that do not involve the Township and they were asked to deal with it in the correct manner by the board.

ACCEPT LIQUOR LICENSING SURRENDER OF JTW ENTERPRISES LLC, GRUMPY'S: Motion by Lubensky and second by Tinker to accept the liquor license surrender from JTW Enterprises, LLC as presented. Motion carried.

CONSIDER/APPROVAL FOR ORIGINAL LIQUOR LICENSING APPLICATION OF WURZER'S GRUMPY'S, LLC: Motion by Tinker and second by Lubensky to approve the original liquor license for Wurzer's Grumpy's, LLC as presented. Motion carried.

REVIEW AND CONSIDER ESTIMATES FOR TOWN HALL IMPROVEMENTS: The Board reviewed the estimate. After discussion, Chairman Whitehead will meet with the contractor to address concerns and bring answers back to the next Town Meeting in March.

UPDATE ON BIRCHWOOD FOUR CORNERS EMERGENCY SERVICE DISTRICT FUNDRAISING AND BUILDING: The clerk reported on the last BFCESD meeting and explained about the fundraiser coming up in Birchwood. The board made the decision that it was appropriate to hang fliers for the spaghetti dinner in the kiosk and place them on the Town's Facebook page.

CONSIDER FEDERAL STP ROAD FUNDING: The clerk explained that a new program of Federal monies for local roads will become available from Bipartisan Infrastructure Law. The clerk has set up a meeting with an engineering company to ask more questions about filing. The road projects are covered 20/80 in this program for the next five years.

Spoke with the DNR warden about the bass fishing tournaments and as long as there are under 20 boats no permit is required, but the DNR is revisiting those issues as many towns are concerned with the parking and trash problems that we are experiencing.

Greg: Would like us to keep an eye on the no parking signs Waters Edge Road and Gruenhagen Bay Road and make plans to get them placed in the ground as soon as the frost is out of the ground.
